## **APPEAL CASE NO. 4422 OF 2022** **(CISCO WEBEX Proceedings)**

### **ORDER (FIRST HEARING):**

1. The RTI application is dated 02.07.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 06.08.2022 and Second Appeal was filed in the Commission on 21.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 21.02.2023.
2. The Respondent states that reply/information has already been sent to the appellant on 03.01.2023.
3. The Appellant states that no information has been provided to him.
4. After deliberations, the PIO is directed to supply requisite information to the appellant, under intimation to the Commission, before the next date of hearing. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which strict action will be initiated against him/her as per provisions of the RTI Act, 2005.
