**ORDER:**

1. The RTI application is dated 13.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.07.2022 and the second appeal was filed in the Commission on 21.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.11.2022. Accordingly, the case has been heard today. Shri Ranjit Singh, appellant comes present to attend the hearing through cisco webex and states that he has not been provided any information.
3. Smt. Sheenu Jindal, Junior Assistant comes present in person before the Bench to attend the hearing on behalf of the PIO O/o Estate Officer, PUDA, Patiala and states that point-wise information has been sent to the appellant vide letter dated 15.11.2022 and also produces before the Bench letter dated 15.11.2022. She also explains before the Bench that on point No.1, record is not maintained as sought by the appellant and on point No.2, the appellant has been supplied information.
4. The appellant is apprised of the version of the respondent and that a copy of information supplied will be sent to him along with the order.

5. Post deliberations, the Bench directs the PIO O/o P.D.A. Patiala to call the appellant to his office and allow him access to the relevant official records within a week's time. Then, the information as is identified by the appellant as per his RTI application, be provided to him. The respondent assures the Bench to do the needful.
