## **Appeal Case No. 4446 of 2022 (Video Conference Proceedings)**

ORDER:

1. The RTI application is dated **29.6.2022** vide which the appellant has sought information **regarding complaints filed against him by one Avtar Singh from 11.2.2022 to 16.2.2022**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.8.2022** and Second Appeal was filed in the Commission on **22.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **15.11.2022**.

2. Both parties are present. The respondent PIO, represented by ASI Hakam Singh, from the office of SSP, Patiala and ASI Vikramjeet Singh from the Police Station Urban State, Patiala, are present. As per ASI Vikramjeet Singh, identical information has already been provided to the appellant's wife Smt. Jaswinder Kaur in Appeal Case No. 3108/2022 and 3108/2022. He also stated that an affidavit has also been furnished by the PIO-cum-SHO, Police Station Urban Estate in the aforesaid cases.

3. The RTI applications in all three cases was compared and the information requested in above mentioned cases is not same as that requested in this Appeal Case, as contended by ASI Vikramjeet Singh. The respondent PIO is directed to furnish the pointwise reply/information to the appellant before the next hearing.
