Order

The RTI Application is dated 16.05.2022 vide which the appellant has sought the information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 06.07.2022 and Second Appeal was filed in the Commission on 23.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for 22.11.2022. The case was adjourned due to administrative reasons and fixed for hearing today i.e. 18.01.2023. The appellant has sought the following information:

2. ਅਸਾਮੀ ਨਾਲ ਸਬੰਧਤ ਇਸਤਿਹਾਰ ਜਿਸ ਵਿੱਚੋਂ ਇਹ ਸਪਸ਼ਟ ਹੁੰਦਾ ਹੋਵੇ ਕੇ ਚੈਗੂਲਰ ਡਿਗਰੀ ਕਰਨ ਵਾਲੇ ਉਮੀਦਵਾਰ ਹੀ Eligible ਹੋਣਗੇ ਜਾਂ ਅਪਲਾਈ ਕਰ ਸਕਣਗੇ।
3. The appellant is absent without any intimation to the Commission despite notice of hearing was sent to him through registered post.
4. The PIO states that information has already been provided to the appellant. The PIO has sent a copy of information to the Commission which is taken on record.
4. After hearing the PIO, going through RTI application and reply of the PIO, the Commission accepts the reply of the PIO. A copy of the reply is **being sent** to the appellant along with the order. No more cause of action is required in this case. Hence this case is disposed of and closed. However, the appellant is at liberty to contact the Commission in case of submissions, if any within two weeks from issue of this order.
