ORDER:

1. This order may be read with reference to the order dated 09.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Ajay Sharma, comes present to attend the hearing on behalf of the appellant through cisco webex. He states that no information has been supplied to the appellant yet.
3. Shri Amit Kumar, Senior Assistant O/o GLADA, Ludhiana comes to attend the hearing through cisco webex. He states the information has been supplied to the appellant vide letter dated 06.12.2022 by speed post and copy by e.mail has also been sent to the Hon'ble Commission regarding the same.
4. The representative of appellant is advised to point out deficiencies to the PIO on receipt of information by the appellant which will be removed by the PIO before the next hearing. On asking the appellant to come present in person before the Bench on the next hearing, the representative of the appellant shows reluctance to appear in person and makes allegations of bias by the Bench against the appellant and in favour of the respondent.
5. Certain submissions made by the representative of appellant during the hearing against the Bench were derogatory in nature and uncalled for. The Bench observes that the appellant is advised to represent his case personally or by another representative during the next hearing. Shri Ajay Sharma has indulged in utterances during the hearing amounting to contempt of court and it is desirable that he may not appear in future hearings.
6. The Bench also directs the PIO O/o GLADA, Ludhiana to comply with the directions of the Bench and ensure to come present in person before the Bench on the next hearing.
7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 24.01.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the parties.
