**ORDER:**

1. This order may be read with reference to the order dated 06.12.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Balbir Aggarwal, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Amit Kumar, Senior Assistant O/o GLADA, Ludhiana comes to attend the hearing through cisco webex. He reiterates his statement made during the previous hearing that the information has been supplied to the appellant vide letter dated 06.12.2022 by speed post and that Shri Sunit Singla, Senior Assistant is also present in the Commission before another Bench who will also show the original record by appearing before Hon'ble Bench.
4. Since the appellant is absent, he is contacted on his mobile phone. He denies the receipt of complete information and states that he has been supplied information other than that desired by him vide his RTI application.
5. Shri Sunit Singla, Senior Assistant also appears in person before the Bench and shows the relevant record and states that the information supplied is as generated through the computer and beyond that, no other information is available in the official records related to RTI application of the appellant.
6. The Bench also peruses the information supplied as also the records brought along and is convinced that adequate information stands supplied.

7. Since the appellant is not satisfied with the information supplied, the PIO is directed to file an affidavit on e.stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in appeal case No.4483/202 and as generated through Computer has been supplied to the appellant and nothing beyond that is available in the records. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

8. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the parties.
