ORDER:

1. The RTI application is dated **9.6.2022** vide which the appellant has sought information **regarding Notices issued to Residential Welfare Association (RWA)**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **12.7.2022** and Second Appeal was filed in the Commission on **27.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **18.1.2023**.
