ORDER:

1. The RTI application is dated **13.6.2022** vide which the appellant has sought information:-

*"1. Provide the Certified Copy of Complete Information (falling within the meaning of Section- 2 (f) read with Section- 2 (j) of the RTI Act, 2005) along with Note Sheets generated in connection to the aforesaid letters while taking action over the matter and as available on the records of your Public Authority.
2. Provide the Certified Copy of the Information showing the Day to Day Proceedings of the aforesaid letters as available on the records of your Public Authority.
3. If till date, your Public Authority has failed to ensure compliance with Section 4 of the RTI Act, 2005 in compliance with the aforesaid directions issued by the Under Secretary, Department of Administrative Reforms and Public Grievances (Administrative Reforms-1 Branch), Government of Punjab vide his aforesaid letters, then Provide the Reasons for the same as available on the record of your Public Authority.
4. If till date, your Public Authority has failed to ensure compliance with Section 4 of the RTI Act, 2005 as asked above, then Provide the Name & Designations of the Officers responsible for showing the Non-Compliance with Statutory Law and the directions issued by the by the Under Secretary, Department of Administrative Reforms and Public Grievances (Administrative Reforms-1 Branch) Government of Punjab"*

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **26.7.2022** and Second Appeal was filed in the Commission on **27.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **18.1.2023**.

2. The appellant is absent. The respondent PIO, represented by Ravinder Kumar, Clerk, has submitted a copy of a reply, which has also been endorsed to the appellant, vide Letter No. 6568 Dated 26.12.2022. Herein, the status of the cited compliance of the Section 4 of the RTI Act, 2005, has been provided along with copy of a letter issued to the various branches of the Improvement Trust with the accompanying noting.
