ORDER:

1. The RTI application is dated **20.6.2022** vide which the appellant has sought information **regarding seasonal tenders 2021-2022**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **25.7.2022** and Second Appeal was filed in the Commission on **29.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **2.12.2022**.

2. The appellant is absent without intimation. The respondent PIO-cum-District Mandi Officer, Sh. Davinder Singh, is accompanied by Jaswinder Singh, Secretary Market Committee Fazilka and Beant Singh, Secretary Market Committee Arniwala. As per the respondent PIO the information pertaining to Market Committee Fazilka was sent to the appellant vide Letter No. 820 Dated 4.8.2022, along with some 29 pages of information pertaining to four points of the RTI application. The information pertaining to Arniwala was sent vide Letter No. 643 Dated 17.11.2022. However, the Commission notes that in this Second Appeal, submitted to the Commission on 29.9.2022, the appellant has contended that he has not received the complete information.

3. In view of the above, the respondent PIO is hereby directed to submit copies of the replies sent to the appellant vide Letter No. 820 Dated 4.8.2022 and Letter No. 643 Dated 17.11.2022, along with duly attested copies of the accompanying information to the Commission forthwith.
