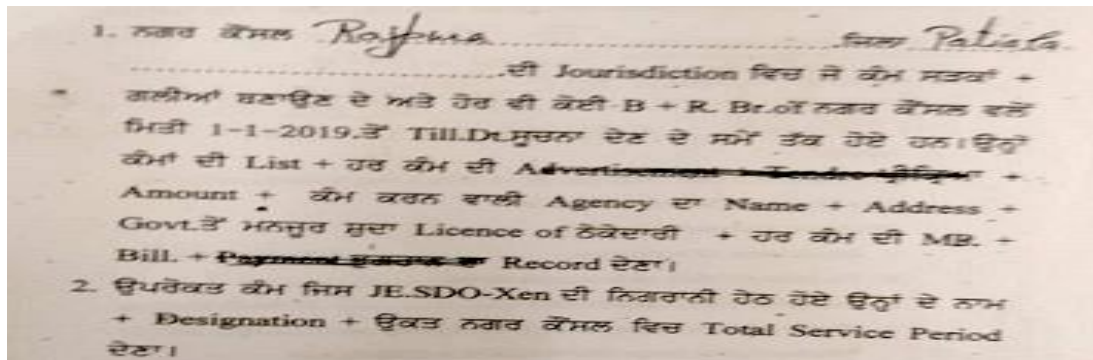

## Appeal Case No. 455 of 2022

2. At the last hearing on 14.9.2022, Show Cause Notice was issued to the PIO, Municipal Engineer, MC Rajura, to which a reply has been submitted vide Letter No. 4765 Dated 15.11.2022 by the EO, MC, Rajpura. However, in a letter sent to the appellant vide Letter No. 243 Dated 1.11.2022, the PIO has stated that the requested information is “voluminous and non-specific” and in case the appellant requires any specific information pertaining to specific work, he can request the same from the office of the EO, MC, Rajpura.

3. The Commission has examined the reply along with RTI application and is of the view that this addresses the said RTI application adequately. This Appeal Case is accordingly **Disposed of**.
