ORDER

1. This order may be read with the reference to the previous order dated 18.05.2023 and matter was adjourned for today.
2. In today's hearing, the appellant, Sh. Ankit Sehgal states that no information has been supplied to him.
3. The respondent PIO is absent without any intimation to the Commission. He was also absent on previous hearings held on 31.01.2023 and 28.03.2023, which indeed a serious matter. It is observed that copy of supplied reply to the appellant is received in the Commission vide letter no. 2791 dated 07.03.2023, vide diary no. 6606 dated 13.03.2023 stating therein that

4. After hearing the appellant and examining the case file, a final opportunity is awarded to the respondent PIO to represent this case on the next date of hearing along with directions to supply the point-wise information to the appellant within fifteen days after receipt of this order, failing which show cause will be issued to the concerned respondent PIO. A copy of this order along with RTI application be sent to him through registered pots for his ready reference.
5. The appellant is also advised to point out deficiencies within 7 days from the receipt of information, failing which the case shall be decided on merits.
6. With the aforesaid directions, **the matter is adjourned for further hearing on 12.07.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application)**. Copy of the order be sent to the parties.
