ORDER

1. The RTI application is dated 28.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 06.07.2022 and the second appeal was filed in the Commission on 30.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today in the Commission's office at Chandigarh. Shri Rajeev Kumar, appellant is absent but an email has been received in the Bench vide which a letter dated 14.11.2022 is attached in which the Appellant has requested for an adjournment due to his personal reasons.

Shri Tarun Kumar, Building Inspector states that this information relates with the Office of Municipal Corporation, Amritsar and appellant can gather the information directly from the office of MC, Amritsar. The same has been informed to the appellant through letter dated 06.06.2022 and copy of the same has been submitted to the Bench during the hearing.

Post deliberations, the **PIO office of Municipal Corporation, Amritsar be impleaded as a respondent in this case** and the Bench directs the PIO to supply the information to the Appellant as per RTI application before the next hearing. A copy of this order along with the RTI application be sent to the PIO O/o MC, Amritsar through registered post. Both the PIO's are directed to appear in person on the next hearing.

5. **With the aforesaid directions, the matter is adjourned. All the concerned parties are directed to attend the hearing on 19.12.2022 at 11.30 am before the Bench at Punjab State Information Commission, Madhya Marg, Sector 16, Chandigarh. Copies of the order be sent to the concerned parties.**
