2. Both parties are present. The appellant is present via Video Conference from Amritsar. The respondent PIO-cum-Assistant Registrar, Sh. Kapil Bansal has submitted a detailed reply to this Commission's Notice of Hearing vide Letter No. 16448-50 Dated 6.12.2022, along with copies of the information supplied by the concerned offices and duly conveyed to the appellant vide Memo No. 8160 Dated 8.7.2022 and Memo No. 933 Dated 9.8.2022.

3. The Commission has examined the PIO's reply and the appended information and is of the view that this adequately addresses this RTI application. There is no further cause for action and this Appeal is accordingly **Disposed of**.
