ORDER

1. The RTI application is dated 26.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 21.06.2022 and the second appeal was filed in the Commission on 03.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today in the Commission's office at Chandigarh. Shri Kuldip Kumar, appellant states that no information has been supplied to him.
3. Nobody appears from the department relating to this case and no letter / email has been received from the Respondent / PIO for today's adjournment.
