## 1. The RTI application is dated **3.7.2022** vide which the appellant has sought information:

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **1.10.2022** and Second Appeal was filed in the Commission on **3.10.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **8.12.2022**.

2. The appellant is absent without intimation. The respondent PIO-cum-BDPO, Rajpura who was issued Show Cause Notice at the last hearing on 8.12.2022, is represented by Sh. Ravinder Singh, PIO-cum-Panchayat Secretary and Munshi Ram, Sarpanch Nalas Khurd. As per Sh. Ravinder Singh, the requested record is not only voluminous but is with the State Vigilance Bureau and the DDPO Office, pending an enquiry by the Bureau. Sh. Ravinder Singh was given an opportunity to inform the appellant. The respondent PIO has accordingly informed the appellant Sh. Ranjit Singh, vide Letter Dated 12.1.2023 which is received in the Commission via email Dated 16.1.2023.

3. The respondent PIO-cum-Panchayat Secretary, Sh. Ravinder Singh, is hereby directed to supply the requested record to the appellant byway of duly attested copies as soon as it is received back from the Vigilance Bureau and the office of DDPO, Patiala.
