ORDER:

1. The RTI application is dated 07.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.11.2022 and the second appeal was filed in the Commission on 09.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. Shri Gurmej Lal attends the hearing on behalf of the appellant through cisco webex and states that no information has been supplied to the Appellant so far.
3. Shri Rajeev Kumar, Building Inspector from O/o Local Govt. states that the status of complaint under reference is available with the PIO O/o Executive Officer, Nagar Council, Jagraon and PIO O/o Additional Deputy Commissioner, (Urban Development), Ludhiana. Local Government has transferred the RTI application under Section 6(3) of the RTI Act, 2005 vide endorsement letter number 2971 dated 07.11.2022 to them. In relation to this, he further submits a copy of letter number 575 dated 07.03.2023 and letter number 2970 dated 07.11.2022 to the Bench, which is seen and taken on record.
4. Post deliberations, the Bench accepts the statement given by Shri Rajeev Kumar, BI and the Bench advises Shri Amarjit Singh Dhamotia, Appellant to file a fresh RTI application to the PIO O/o Executive Officer, Nagar Council, Jagraon and PIO O/o Additional Deputy Commissioner, (Urban Development), Ludhiana seeking the information as issues raised by him relate to them.
5. A copy of letter number 575 dated 07.03.2023 and letter number 2970 dated 07.11.2022 be sent to the appellant along with the copy of order for reference.
6. No further cause for intervention is left in this case. **This case is disposed off and closed.** Copies of the order be sent to the concerned parties.
