ORDER:

1. This order may be read with reference to the order dated 13.12.2022 passed by this Bench on the previous hearing..
2. The case has been heard today. Shri Prem Kumar Rattan, appellant has not come present to attend the hearing in person before the Bench or through cisco webex. He has, however sent letter dated 10.12.2022 by e.mail vide which he has stated that due to ill health, he is unable to attend the hearing and that in spite of deficiencies pointed out to the PIO, rectified information has not been supplied to him.

Then he is apprised that a copy of same is being sent along with this order and he should ensure that rectified information, after removing the deficiencies, is supplied to the appellant before the next hearing and also ensure to come present in person before the Bench.
