ORDER

- 1. The RTI application is dated 04.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.08.2022 and the second appeal was filed in the Commission on 04.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 23.11.2022. Accordingly, the case has been heard today. Shri Randhir Singh comes present to attend the hearing in person before the Bench on behalf of the appellant Ms. Rajni. He states that partial information has been supplied to the appellant.
- 3. Shri Gursharan Singh, Clerk O/o Estate Officer, PUDA, Amritsar comes present in person before the Bench to attend the hearing on behalf of the PIO. He states that point-wise information has been given to the appellant vide letter dated 18.11.2022 by registered post. He states that the house as mentioned in RTI application of appellant has been allotted to one Shri Harwinvder Singh, being a riot affected person.
- 4. The representative of appellant states that the copy of request letter of the allottee of aforesaid house has not been supplied to the appellant.
- 5. The PIO is now directed to call the appellant to his office and allow him access to the relevant official record. The appellant, after inspection of relevant records, will identify the information as per his RTI application. The PIO is directed to supply complete information to the appellant as may be identified by him The Bench also directs the respondent to supply copy of the said application of Shri Harwinder Singh. The representative of PIO assures to provide the copy of said application to the appellant.
- 6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
