**ORDER**

1. The RTI application is dated 23.02.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.06.2022 and second appeal was filed in the Commission on 04.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 01.02.2023 i.e. today
3. In today's hearing, the appellant states that no information has been supplied to him.
4. Respondent, Ms. Sarabdeep Kaur states that the category is not clear for information sought for and requests the appellant to intimate for the same.
5. On this the appellant states information is required in relation to Class -3 category.
6. In view of above, the PIO concerned is directed to supply the attested point wise information of Class -3 category as per RTI application to the appellant within ten days from today along with directions to appear in person on the next date of hearing to represent this case.
7. The Appellant is also advised to go through the information, once he had received and point out specific discrepancies, if any, in writing to the Respondent / PIO with a copy to the Commission after receipt of information within seven days, failing which it would be presumed that she has nothing to say in this regard.
8. With the aforesaid directions, the matter is adjourned for further hearing on **11.04.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
