ORDER

- 1. The RTI application is dated 09.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.08.2022 and second appeal was filed in the Commission on 04.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

- 3. In today's hearing, the appellant states that no information has been supplied to him.
- 4. Respondent, Ms. Sarabdeep Kaur states as under:
 - Point No. 1 & 2:-Information was sent to the appellant yesterday i.e. 31.01.2023.
 - Point No. 3:- Information could not be supplied as per letter dated 09.08.2021 of the Punjab Government.
 - Point no. 4:-matter is under process/investigation, so it could not be supplied.
- 5. On this, appellant denies the statement of the respondent and states that enquiry has been completed more than a year ago in connection with point no. 4.
- After hearing both the parties and examining the case file, appellant is directed to send the deficiencies letter to the department through registered post within two to three days with a copy to the Commission.
