ORDER:

5. Respondent PIO is also directed to submit a copy of the affidavit in connection with point no. 4 of the RTI application, as per directions of the Commission vide order dated 01.02.2023.

He is also directed to remove discrepancy if any pointed out by the appellant in the supplied information on 25.04.2022 along with directions to represent this case on the next date of hearing, so that case could be concluded accordingly.

6. This case is adjourned and both the parties are directed to come up on **15.06.2023 at 11:00 A.M. through CISCO-Webex**. Copy of the order be sent to the parties.
