## ORDER

1. The RTI application is dated 04.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.08.2022 and the second appeal was filed in the Commission on 06.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 23.11.2022. Accordingly, the case has been heard today. Shri Madan Lal, appellant comes present to attend the hearing in person before the Bench and denies receipt of information and states that he has not been explained the use of word 'Doshi' by the DSP Gidderbaha. A person cannot be 'Doshi' until the Court of Law decides so.

3. Shri Jasbir Singh, DSP, Gidderbaha comes present to attend the hearing in person before the Bench and states that reply was given to the appellant vide letter dated 22.07.2022. He also hands over a copy of the letter 18.11.2022 to the appellant in the court itself, explaining therein the position as per law regarding the contention of the appellant.

4. Post deliberations, the Bench is convinced that adequate information has been supplied to the appellant as per official records and does not feel need for further intervention in the matter.

5. In view of the above, no further cause of action is left in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
