**ORDER**

1. This order may be read with reference to the order dated 14.12.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Sukhbir Singh Mahal, appellant comes present to attend the hearing through cisco webex. He denies receipt of information and also alleges that the file relating to the information sought by him is missing from the office of M.C. Amritsar.
3. Shri Dheeraj, Building Inspector, O/o Municipal Corporation, Amritsar comes present to attend the hearing on behalf of the PIO through cisco webex. He states that information has been sent to the appellant on 13.12.2022 by registered post.
4. On the asking of the Bench, the representative of PIO Shri Dheeraj is not able to clarify the position with regard to the contention of appellant that the relevant file is not available with the Municipal Corporation, Amritsar.

Post deliberations, the Bench directs the PIO O/o Municipal Corporation, Amritsar to supply point-wise information to the appellant and bring along the entire relevant record and produce the same before the Bench on the next hearing.
