ORDER

1. This order may be read with reference to the order dated 08.02.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Sukhbir Singh Mahal, appellant has not come present to attend the hearing either in person before the Bench or through cisco webex.
3. Shri Munish Arora, Building Inspector, O/o Municipal Corporation, Amritsar comes present to attend the hearing on behalf of the PIO in person before the Bench. He submits written reply mentioning therein that information as per official records has been provided to the appellant by hand on 12.04.2023.
4. Since the appellant is absent, he is contacted on his mobile phone. He expresses dissatisfaction over the version of the representative of PIO Shri Munish Arora and states that partial information has been provided to him. Photographs of the gate along with ramp pertaining to house under reference are pending and inputs related to adjoining house have been provided.
5. The Bench, on perusal of documents available on file of the appellant and hearing the version of Shri Munish Arora, Building Inspector O/o MC, Amritsar observes that the information as available in the official records stands supplied to the appellant. Now, the Bench directs the PIO O/o MC, Amritsar to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.4688/2022 has been supplied to the appellant. It be further stated that the information supplied is true and correct and nothing has been concealed therein. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
6. With the aforesaid directions, the instant appeal case is hereby, **disposed off and closed**. Copies of the order be sent to the parties.
