#### ORDER:

- 1. The RTI application is dated 13.7.2022 vide which the appellant has sought information regarding Complaint Diary No. 13686 Dated 13.10.2014 against Sh. Sadhu Singh, Assistant Labour Commissioner, Ferozepur, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 26.7.2022 and Second Appeal was filed in the Commission on 10.10.2022 under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on 13.12.2022.
- 2. The appellant is absent but has informed the Commission that he has received the requested information and wishes to withdraw this Appeal Case. The respondent PIO, represented by Sh. Parminder Singh, Superintendent, states that a reply along with requested information was provided to the appellant vide Letter No. 10203 Dated 10.10.2022.
- 3. The Commission notes that this RTI application was submitted on 13.7.2022 and the respondent PIO-cum-Labour Commissioner Conciliation Sh. Jashandeep Singh, has failed to provide suitable reply and the requested information within the stipulated period of 30 days. The Commission deems it fit to issue this Show Cause Notice to the PIO-cum-Labour Commissioner, Conciliation, Sh. Jashandeep Singh.
- 4. The respondent <u>PIO-cum-Labour Commissioner, Conciliation, Sh. Jashandeep Singh</u>, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **13.7.2022**.
