as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **26.7.2022** and Second Appeal was filed in the Commission on **10.10.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **13.12.2022**.

2. The appellant is absent. The respondent PIO-cum-Assistant Labour Commissioner, Sh. Jashandeep Singh, who was issued a Show Cause Notice at the last hearing on 13.12.2022, has submitted a written reply to said Show Cause Notice wherein he has explained the reasons for the delay in addressing the RTI application.

3. The Commission has examined said reply and is satisfied that there was no malafide intent on the part of the PIO to delay/deny the requested information. This Appeal Case is accordingly **Disposed of**.
