- Certified copy of the agreement (Rajinama) dated 07-02-2022 of both the families under their signatures attached with the report of the I.O./ Presiding Officer.
- Certified copy of the Medical report of Bimal Gill S/o Sh. Bachan Singh sought by the I.O./ presiding officer during the course of hearing.
- Certified copy of the marriage expenses bills dully submitted by the complainant Mrs.
   Megha W/o Bimal Gill D/o Sh. Kamaljit.
- Certified copy of the I.O./ Presiding officer report on the complaint dated 28-01-2022, after hearing both the parties on 07-02-2022 and date wise further action on the report by the police Authority

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **3.5.2022** and Second Appeal was filed in the Commission on **10.10.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **14.12.2022**.

- 2. Both parties are present. As directed at the last hearing on 14.12.2022, the respondent PIO has submitted a reply to the appellant vide Letter No. 102943 Dated 17.12.2022 including a pointwise reply to the RTI application and the certified copy of an information requested therein. The information includes copy of the complaint Dated 28.1.2022-annexure 1; copy of statement. i.e. complainant Mrs. Megha-annexure 2; copy of document of articles handed over to the complainant Mrs. Megha and her family-annexure 3; copy of the agreement/rajinama-annexure 4; and copy of the IO's report-annexure 5. The information at point no. 4, i.e. the document of articles in annexure 3 of the PIO's reply was not attested.
- 3. The respondent PIO's representative, Head Constable, Gurpreet Kaur, from the RTI Cell, office of SSP, Jalandhar (Rural), has attested the same at this hearing. The request for information has now been fully addressed. This Appeal is accordingly **Disposed of**.
