First Appeal was filed with the First Appellate Authority (FAA) on **23.7.2022** and Second Appeal was filed in the Commission on **10.10.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **14.12.2022**.

2. Both parties are present. As per a reply received from the respondent PIO vide Letter No. 23A-1 Dated 6.12.2022, the matter cited in the RTI application is still under consideration with additional CP-1, Jalandhar, which is why the requested information is withheld. As per Head Constable Mrs. Jyoti Sharma, who is present on behalf of the respondent PIO, the appellant was similarly informed vide Letter No. 65ACP-1 Dated 13.9.2022 as well as in an earlier communication.
