<u>ORDER</u>

1.

This is with reference to the order dated 21.11.2022 passed by this Bench on the previous

hearing.

2. The case has been heard today. Shri Ravinder Kumar, appellant comes present to attend the hearing in person before the Bench and states that no information has been received by him yet.

3. Shri Kulwinder Singh, Superintendent, Shri Simarpreet Singh, Junior Engineer and Shri Chandan, Senior Assistant O/o GMADA, Mohali and Shri Hardip Singh, Patwari, Tilla Consultants, C/o GMADA. Mohali come present in person before the Bench to attend the hearing on behalf of the PIO. Shri Simarpreet Singh, J.E. (Civil) states that the appellant sought demarcation report of PR-7 road contending it to be 176 feet wide stating 24 feet to be un-acquired chunk and further states that this road is 200 feet wide. However, regarding the fact as to whether the part of road belongs to the appellant, no ownership of the appellant is established from the record and it amounts to third party information. He further states that the said land was acquired from the Land Developer Shri Bajwa. He further produces before the Bench letter dated of M/s Bajwa Developers Ltd. wherein the company has stated that his company is in ownership of colonies being developed after proper approval and that PR-7 Road is in its ownership and has further requested not to share any information without the consent of Company.

4. The appellant contends that he has sought information with regard to the letter of Chief Engineer, GMADA that this road is not in possession of GMADA, Mohali.

5. Post deliberations, the Bench observes that the appellant has sought information regarding a road which has been build in the interest of public and directs the PIO to supply information to the appellant as per official records of GMADA irrespective of the ownership of land, clarifying the issue raised by the appellant and without disclosing any personal information and details of compensation awarded, before the next hearing.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 30.01.2023 at 11.30 AM in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
