ORDER

1. The RTI application is dated .06.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 22.07.2022 and the second appeal was filed in the Commission on 11.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 22.11.2022. Accordingly, the case has been heard today. Shri Lokesh Gupta, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Ashok Kumar, PIO O/o PUDA, Mohali comes present to attend the hearing through cisco webex and states that the RTI application has been transferred to Chief Town Planner, Punjab, SAS Nagar. However, on perusal of letter dated 21.11.2022 of Chief Town Planner, Punjab available in the case file, the information does not relate to their office.
4. Post deliberations, the PIO PUDA states that the RTI application has been transferred to PIO O/o GLADA, Ludhiana under sections 5(4), 6(3) of RTI Act, 2005 vide letter dated 17.11.2022. Accordingly, the PIO O/o GLADA, Ludhiana is directed to supply information to the appellant before the next hearing.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 14.12.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
