**ORDER:**

1. The RTI application is dated 07.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 21.10.2022 and the second appeal was filed in the Commission on 09.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.03.2023. Accordingly, the case has been heard today. The appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been given by him in this regard.
3. The respondents state that information has been supplied to the appellant vide letter dated 11.10.2022 by registered post. Subsequently, no observations have been received from the appellant.
4. The appellant is contacted on his mobile phone. He is apprised of the version of PIO O/o Secretary, Market Committee, Abohar, Distt:Fazilka. He does not express satisfaction over the reply of PIO and states that he has not received any reply from the respondent.
5. Post deliberations and after examination of document available on file. The Bench is of the opinion that adequate information stands supplied. The respondent O/o Secretary, Market Committee, Abohar, Distt:Fazilka is directed to again send copy of reply to the appellant through registered post.
6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
