ORDER

- This order may be read with reference to the order dated 22.11.2022 passed by this Bench on 1. the previous hearing.
- 2. The case has been heard today. Shri Keshav Rai, appellant comes present to attend the hearing through cisco webex and states that information has been received by him, however, the same has not been supplied as sought vide his RTI application.
- 3. Shri Bahadur Singh, SDO, and Shri Pal Singh, AAE, PSPCL Sub Division, Raman, Distt. Bathinda, come present to attend the hearing on behalf of the PIO/Respondent in person before the Bench. Shri Pal Singh states that the information was earlier supplied vide letter dated 25.08.2022 by registered post and as per directions of Hon'ble Bench, the information has been again sent vide letter dated 05.12.2022 by registered post with a copy to the Commission responding to each point.
- 4. The appellant is apprised of the version of respondents. He expresses dis-satisfaction over the information supplied and insists on the information being provided exactly as per his RTI application. The respondent explains to the appellant information on each point, stating that the record being very old, copies of the alternative documents existing in the record have been provided to him and the same has also been stated in the reply given to the appellant.

5. Post deliberations, the Bench is convinced that adequate information has been supplied to

appellant is still not convinced with the information supplied, the Bench directs the PIO PSPCL, Raman,

and attested by the Notary Public to the effect that the information as available in the official records in AC

No.4770 of 2022 has been supplied to the appellant. It be further stated that nothing has been concealed

therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the

same be sent to the Commission for record.

6. With the aforesaid directions, the instant appeal case is disposed off and closed. Copies

of the order be sent to the concerned parties.
