as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **3.7.2021** and Second Appeal was filed in the Commission on **22.10.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **11.10.2022**.

- 2. The appellant is absent without intimation for the fourth successive hearing. As directed at the last hearing, the respondent PIO, represented by Sh. Aman Puri, ETO, has submitted copy of the Final Order in Appeal Case No. 3793 of 2021 which was Disposed of by the SIC Sh. Amritpartap Singh Sekhon on 11.3.2022. He has also provided details of the information given to the appellant in Appeal Case No. 3793 of 2021, where the appellant had requested almost identical information.
- 3. This Appeal is accordingly **Disposed of**.
