1. The complainant, **Lakshman Dass Gupta**, filed this RTI application dated **10.9.2021** and sought information:

from the PIO o/o **Improvement Trust, Ludhiana**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **21.7.2022**. Notice was issued to the parties for first hearing in the Commission on **10.11.2022**.

2. Both parties are absent. As per the Complaint Filed by the complainant Sh. Lakshman Dass Gupta, Advocate, he wishes to obtain the information requested in his RTI application i.e. copies of resolutions by the Improvement Trust from 22.10.2020 to 10.9.2021. This is however, a Complaint Case whereby the Commission is not mandated to ensure the supply of information to the complainant.
