The RTI application is dated **17.5.2021** vide which the appellant has sought information **regarding the constitution of an SIT in response to his application dated 8.6.2007**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **23.6.2021** and Second Appeal was filed in the Commission on **22.10.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **12.8.2022**.

The PIO-cum-SHO, PS Sadar Nabha was issued a Show Cause Notice vide this Commission's Order of 12.8.2022. Smt Priyanshu Singh is further directed to be present in person at the next Hearing on 31.10.2022.
