## Appeal Case No. 4800 of 2021

### ORDER:

*(To be read in continuity with earlier orders on 28.4.2022, 12.8.2022, and 11.10.2022)*

1. The RTI application is dated **17.5.2021** vide which the appellant has sought information **regarding the constitution of an SIT in response to his application dated 8.6.2007**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **23.6.2021** and Second Appeal was filed in the Commission on **22.10.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **11.10.2022**.

2. Both parties are present. At the last hearing on 11.10.2022, the respondent PIO-cum-SHO, Police Station Sadar Nabha, Smt. Priyanshu Singh, was directed to be present in person at today's hearing along with a duly notarized affidavit by way of a pointwise reply to the RTI application. The PIO, is neither present and nor has she submitted any information/reply pertaining to this RTI application, which has sought information regarding the constitution of an SIT as enumerated in his RTI application.

3. The respondent PIO is given a final opportunity to submit the aforesaid affidavit along with the affidavit and information in response to Case No. 4801/2021 on 4.11.2022. Also in view of the above:

4. In view of the harassment and detriment caused to the appellant, **Sukhdev Singh**, this Commission deems it appropriate to award a **compensation of Rupees Fifteen Thousand (Rs. 15,000.00)**. This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, the **Station House Officer, Police Station Sadar, Nabha, Patiala**, within 15 days of receiving this Order. Proof of payment is to be submitted to this Commission.
