**ORDER:**

1. The RTI application is dated 1.7.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 5.8.2022 and second appeal was filed in the Commission on 14.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 16.2.2023 at 11.00a.m. i.e. today.

3. Respondent, Ms. Jasdeep Kaur states that information had already been supplied to the appellant two to three times as per the concerned branch.

7. Both the parties are directed to appear in person on the next date of hearing along with relevant record, failing which case will be decided on merit basis.
