**ORDER:**

1. The RTI application is dated 29.6.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 5.8.2022 and second appeal was filed in the Commission on 14.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 16.2.2023 at 11.00a.m. i.e. today.
2. In today's hearing both the parties are present.
3. The appellant states that he has made a request with the respondent on 29.6.2022 for seeking record which relates to his promotion but the same is still awaited. He further adds that information was denied on the plea that demanded information is in question form and the same is exempted under RTI rules.
4. The respondent, Dr. Jasdeep Kaur states that the relevant information has already been provided to the appellant in similar other RTI applications, so RTI application in the instant appeal case was not dealt with by the department.
5. After discussing with both the parties and examining the case file, respondent PIO is directed to supply the information as per RTI application to the appellant within ten days from today through registered post along with directions to send a copy of the same to the Commission with a copy of postal receipt without further delay.
6. A copy of this order be sent to Dr. Jasdeep Kaur by name through registered post for her ready reference.
7. Both the parties are directed to appear in person on the next date of hearing along with relevant record, failing which case will be decided on merit basis.
8. **Matter is adjourned for further hearing on 15.03.2023 at 11:00 AM at Punjab State Information Commission, Sector 16, Madhya Marg, Chandigarh.** Copy of the order be sent to the parties.
