ORDER:

1. This order may be read with reference to the order dated 20.12.2022 passed by this Bench on the previous hearing.

3. The case has been heard today in the Commission's office at Chandigarh. Shri Gurmej Lal, comes present to attend the hearing on behalf of the appellant through cisco webex and states that no information has been supplied to the appellant.

Shri Vijay Kumar, ATP O/o Director, Local Govt., Punjab, Chandigarh comes present in person before the Bench and states that action taken report on his complaint dated 23.06.2022 has been sought by the appellant and the same was transferred u/s 6(3) to the Municipal Corporation, Ludhiana under whose jurisdiction the unauthorised buildings being constructed fall, vide e.mail dated 29.07.2022. The PIO O/o Municipal Corporation, Zone-C, Ludhiana has again been directed to take action on the complaint and supply information to the appellant vide letter dated 03.08.2022, copy of which has also been sent to the appellant.

4. The representative of the appellant is apprised of the statement made by the respondent before the Bench and that the requisite information is to be supplied to the appellant by the Municipal Corporation, Ludhiana. Now, the Bench directs the PIO O/o Zone-C, Municipal Corporation, Ludhiana, to supply information to the appellant.
