**ORDER**

1. The RTI application is dated 21.10.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.12.2021 and the second appeal was filed in the Commission on 17.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today in the Commission's office at Chandigarh. Shri Suresh Kumar Sharma, appellant states that no information has been supplied to him.

3. Shri Paramjit Singh, Junior Assistant requests for an adjournment relating to the case.

4. Post deliberations, the Bench accepts the request made by the respondent during the hearing. The Bench directs the PIO to send point wise attested copies of information to the appellant through registered post and supply the copy of postal receipt to the Bench before the next hearing. The PIO is also directed to appear before the Bench along with official record on the next hearing.

5. The Appellant is directed to go through the supplied information and point out the deficiencies, if any, after the receipt of the information. The Appellant is also directed to attend the next hearing positively failing which it will be presumed that he has nothing to say and the case may be decided based on documents available on file.

6. **With the aforesaid directions, the matter is adjourned. Both the concerned parties are directed to attend the hearing on 02.02.2023 at 11.30 am before the Bench at Punjab State Information Commission, Madhya Marg, Sector 16, Chandigarh.** Copies of the order be sent to the concerned parties.
