**ORDER:**

1. The RTI application dated 26.5.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.7.2022 and second appeal was filed in the Commission on 17.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 16.2.2023 at 11.00a.m. i.e. today.
2. In today's hearing both the parties are present.
3. The appellant pleads that sufficient time has elapsed but the information with regard to point No.3 and 4 of his RTI application is still to receive.
4. The respondent states that record in connection with point No.3 and 4 is lying in the Head Office, Chandigarh.
5. After hearing both the parties and examining the case file, respondent PIO is directed to collect the pending information (point No.3 and 4) as per RTI application and supply it to the appellant within fifteen days after receipt of this order.
6. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
7. A copy of this order be sent to the First Appellate Authority by name through registered post to look into the matter and deal this case on priority so that case could be concluded on the next date of hearing positively.
8. To come up on **11.05.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties through **registered post.**
