**ORDER:**

1. The RTI application is dated 24.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 25.10.2022 and the second appeal was filed in the Commission on 09.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today. As per appellant, the PIO has not supplied any information so far.

3. As per respondent, the information is voluminous and not specific and a reply has been sent to the appellant vide letter dated 01.03.2023. However, the information on point-6 (name of JE/SDO/XEN/SE) has been provided. The respondent has also submitted a copy of reply to the Commission which has been taken on record.

4. Having gone through the RTI application and reply of the PIO, the Bench directs the PIO to call the appellant to his office on any working day and allow him access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to him before the next hearing.

5. The appellant is advised to contact Shri Ankush Sharma, Junior Engineer - Mobile No.7981605351 prior to visiting for inspection of records. The PIO is directed to ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO. The PIO is directed to come present in person before the Bench to attend the next hearing. The appellant is also directed to be present in person before the Bench on the next date of hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 22.05.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
