**ORDER:**

1. This case may be read with the reference to the previous order dated 21.12.2022.
2. In today's hearing, Shri Suresh Sharma, appellant states that no information has been supplied to him.

4. Post deliberations, another opportunity is given to the PIO. The Bench directs the PIO to send point wise attested copies of information to the appellant through registered post and present a copy of postal receipt to the Bench on the next hearing. The PIO is also directed to appear before the Bench with official record along with the reply to the show cause notice on the next hearing.

5. The Appellant is directed to go through the supplied information and point out the deficiencies, if any, after the receipt of the information. The Appellant is also directed to attend the next hearing failing which it will be presumed that he has nothing to say and the case may be decided based on documents available on file.

6. **With the aforesaid directions, the matter is adjourned. Both the concerned parties are directed to attend the hearing on 05.04.2023 at 11.30 am before the Bench at Punjab State Information Commission, Madhya Marg, Sector 16, Chandigarh.** Copies of the order be sent to the concerned parties.
