## ORDER:

1. The RTI application is dated 06.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.11.2022 and the second appeal was filed in the Commission on 09.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

The PIO is again directed to contact the appellant on his mobile No.9781672776 and get a copy of complaint if not available in the record. Both the parties to come present in person before the Bench to attend the next hearing.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on
22.05.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
