ORDER

1. The RTI application is dated 14.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 29.06.2022 and the second appeal was filed in the Commission on 24.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today in the Commission's office at Chandigarh. Shri Balam Singh, SDO and Shri Bawa Singh, SDO hands over the information to Shri Mohan Singh, appellant during the hearing. They also hand over a letter number 7176 dated 19.10.2022 to the bench during the hearing, which is taken on record.

3. After going through the supplied information, Shri Mohan Singh, appellant states that he is satisfied with the supplied information except one point i.e. he needs to know the joining dates of the concerned persons as mentioned in point number 7 of the office of PSPCL, Kharar only.

4. On asking the same from the respondent/ PIO, Shri Balam Singh, PSPCL Ropar states that he will look into this as the data is with the outsourced company.

5. Post deliberations, the Bench directs the PIO to supply the remaining information (i.e. joining dates relating to concerned persons from office of PSPCL Kharar as on point no. 7 of RTI) to the Appellant, Shri Mohan Singh by the next date of hearing through registered post.

6. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.

7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 23.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
