ORDER

1. This order may be read with reference to the previous order dated 28.02.2023.

He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

- 5. Respondent PIO is directed to deal this case on priority basis and supply the complete requisite information within ten days after receipt of this order.
- 6. To come up on 06.06.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application). Copy of the order be sent to the parties.
