**ORDER:**

1. The RTI application is dated 25.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 25.08.2022 and the second appeal was filed in the Commission on 27.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 20.12.2022. Accordingly, the case has been heard today. Shri Jasbir Singh, appellant comes present to attend the hearing through cisco webex. He states that no information has been received by him.

3. Shri Bhupinder Singh, Senior Assistant O/o GLADA, Ludhiana comes present to attend the hearing on behalf of the PIO/Respondent through cisco webex. He states that no record relating to the information sought by is available in their office and the reply has been given to the appellant vide letter dated 15.12.2022 by registered post accordingly, with a copy to the Hon'ble Commission sent by e.mail.
