ORDER:

- 1. The RTI application is dated 06.10.2022 vide which the appellant has sought information as enumerated in his RTI application. He/she should file an affidavit in this regard. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such person(s) of the show cause and direct them to appear before the Commission along with the written replies.
- 5. The PIO is directed to provide information to the appellant before the next date of hearing.
- 6. The case is adjourned. Both the concerned parties are directed to come up for hearing on 22.05.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
