**ORDER:**

1. The RTI application is dated 02.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.08.2022 and the second appeal was filed in the Commission on 31.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 04.01.2023. Accordingly, the case has been heard today. Shri Simranjit Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been given by him in this regard.
