**ORDER:**

1. This order may be read with reference to the order dated 04.01.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Shivam, comes present to attend the hearing in person before the Bench on behalf of Shri Ashok Kumar, appellant. He states that the appellant has sent authority letter by e.mail in his favour to attend the hearing on his behalf.
3. Shri Paramjit Singh, Junior Engineer and Shri Vikram Garg, Revenue Accountant, PSPCL Sub Division, Dirba, District Sangrur come present in person before the Bench to attend the hearing on behalf of the PIO. Shri Vikram Garg reiterates the statement as made during the previous hearing for having provided 44 pages and 283 pages to the appellant. He further states that the appellant was called for inspection of records on 24.01.2023 and it was found that information relating to a file is still left. The information relating to that file has been brought along today. On the asking of the Bench, the same is handed over to the representative of appellant during the hearing. He then states that the information as available in the official records has been supplied to the appellant.
4. The representative of the appellant states that the appellant has sought information on eight points, whereas information on Point No.4 to 8 has not been supplied to the appellant yet.

Post deliberations, the notified PIO is directed to file an affidavit on e-Stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.5065/2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
